About Herefordshire Marches Federation of Academies (HMFA)

HMFA are a Charitable Trust, there are four schools within the Multi Academy Trust and these are Lord Scudamore Academy, Sutton Primary Academy, Kings Caple Primary Academy and St Weonards Academy, plus three nurseries across the four schools.

Furthermore, there are four Associated schools: Marden Primary Academy, Pencombe CE School, Clehonger CofE Primary School & Llangrove CE Academy. With a total number of 1,180 pupils across the federation of schools.

Whilst all of our academy schools have their own distinct identity, they benefit from the overall management of the HMFA.

The role:-

We are seeking trustees not only with the relevant knowledge and experience but also with strong interpersonal skills, an adaptive approach and a strategic mindset.

Trustees – or non-executive directors – are both charity trustees and company directors of the trust. The trustees ensure compliance with the trust's charitable objects and with company and charity law.

Our Board meets at least three times per year. In addition, the Board currently operates two sub-committees made up of Trustees:

- Finance, Audit & Risk.
- Pay Review

We are keen to recruit from the Herefordshire community, where our schools within the Trust are based but welcome those from further afield who possess the skills and knowledge needed to make a meaningful contribution to our Board.

Expectations of trustees

It is important that trustees fully understand what is expected of them in their role. This includes:

- Attendance at full Board meetings (minimum of three per year) these are usually held in Hereford between approximately 6pm 8pm.
- Possible additional Membership of a Trust committee and attendance at related meetings, often held remotely online, up to one each term, during the School day
- Commitment to maintain confidentiality and conduct in line with the trust's vision and values;
- Commitment to ongoing training, usually online, in addition to Board meetings;
- Participation in the Board's skills audit and external reviews of governance;
- Undertake a DBS check and provide two satisfactory references.

HMFA is uncompromising in its commitment to safeguarding children and young people.

The Trust is committed to promoting a diverse and inclusive community - a place where we can all be ourselves and succeed on merit, ensuring best practice in our recruitment process is essential to our commitment.
